Subject: Adient Conflict Minerals

Dear Adient Supplier

Adient is committed to responsible business conduct, including compliance with the laws and regulations of each country in which we do business. As stated in our terms and conditions, we expect our suppliers to share our principles and uphold our commitment to compliance. Adient and our suppliers will not directly or indirectly have dealings with an entity that appears on the U.S. Office of Foreign Assets Control's lists of Specially Designated Nationals (SDN) and Blocked Persons.

Adient learned through your Conflict Minerals reporting statement that a supplier that may be part of your supply chain - JSC Ekaterinburg Non-Ferrous Metal Processing Plant is majority owned by entity Renova Group, which is identified as an SDN. It is critical that Adient's supply chain continue to meet all legal and regulatory requirements. Until Renova Group and their majority owned businesses have been removed as an SDN, you and/or your suppliers must discontinue any sourcing from JSC Ekaterinburg Non-Ferrous Metal Processing Plant and begin sourcing from alternate smelters. Adient has communicated that its supply base must remove this smelter numerous times since 2018 via our supplier communications.

To support responsible mineral sourcing, Adient encourages you to use validated conflict free mineral suppliers. To the extent that a supplier refuses to cooperate with our compliance efforts or does not conduct conflict-free sourcing, we may reconsider our supply arrangement and implement remedies available to us.

We request that you please complete the below written statement of assurance, update & resubmit your Conflict Minerals reporting statement and return both to ae-conflict.minerals@adient.com. Please note that you can find this notice as well as other important communications to Adient's supply base on the Supplier Portal (http://www.adient.com/suppliers).
